Also Present: E. W. Ward, City Manager and Bill Bradshaw, City Attorney

Mr. Ward opened the floor for nominations of Mayor.

William Mays nominated Mr. B. Robert Raines to be reappointed as Mayor.

Upon a motion by Joseph Fawbush, seconded by Jack Wallace, and passed by unanimous vote, Council moved that the nominations cease.

Mayor Raines opened the floor for nominations of Vice Mayor.

Mayor Raines opened the floor for nominations of City Clerk.

Joseph Hunnicutt nominated Mrs. Mary Brown to be reappointed as City Clerk.

Upon a motion by Jack Wallace, seconded by William Mays, and passed by unanimous vote, Council moved that the nominations cease.

Mayor Raines declared Mrs. Mary Brown reappointed as City Clerk.

Mayor Raines opened the floor for nominations of City Attorney.

Joseph Fawbush nominated Mr. Bill Bradshaw to be reappointed as City Attorney.

Upon a motion by William Mays, seconded by Joseph Hunnicutt, and passed by unanimous vote, Council moved that the nominations cease.


Council had A Resolution of the City Council of the City of Norton, Virginia Dispensing with Second Reading of Ordinances to act upon.


There being no further business to come before the Council, the meeting was adjourned.
